Sub : Approval for extension of provisional recognition from class Nursery to Secondary level beyond 31.03.2021 upto 31.03.2026 in r/o **Bhardwaj Model School**, RZ Q-88, Near Q-Block Gurudwara, Nihal Vihar, New Delhi - 41.

With reference to your application dated 26.11.2020 on the subject cited above, I am directed to convey the approval of Director of Education, Govt. of NCT of Delhi vide U.O. No. 603/DE dated 01.02.2022 for grant of extension of provisional recognition from class Nursery to Secondary level beyond 31.03.2021 upto 31.03.2026 to **Bhardwaj Model School**, RZ Q - 88, Near Q-Block Gurudwara, Nihal Vihar, New Delhi - 41, subject to following conditions :-

- (i) Final outcome of the notification of MOUD, GoI.
- (ii) That the school shall make payment of salary and other admissible allowances to its teaching/non-teaching staff as per ongoing CPC through ban/RTGS.
- (iii) That the school shall comply with clause 14 or order No. F.DE/15 (56)/ACT/2009778 dated 11/02/2009 in r/o maintenance of DRF. School also ensure to the follow FN-21 "Accounting by school" as issued by the Institute of Chartered Accountants of India (ICAI) for proper accounting treatment.
- (iv) That the school shall comply with the provisions of section 10(1) read with Rule 125 of DSEAR, 1973.
- (v) That the school shall comply with the provisions of DSEAR, 1973, RTE Act, 2009 and direction/instruction/guidelines issued by the Department from time to time.
- (vi) That the school shall comply with the order/guidelines of DOE and judicial pronouncement w.r.t. utilization/maintenance of school funds.
- (vii) That the school shall comply with the orders/guidelines of DOE dated 07/11/2017 and judicial pronouncements w.r.t. safety of the students and shall take all necessary steps to this effect.
- (viii) That the school shall appoint the second special educator once the school re-opened.
- (ix) That the entry level of the school shall now be class Nursery instead of class - I from the session 2022-23 and no additional allotment of EWS candidates at other entry level classes Pre-Primary (KG) & class Ist shall be permitted from the session 2022-23.
